- SELECTS MEDIATION PROVIDER
- EXECUTES ATTACHED FORM
- ATTACHES A TYPED STATEMENT OF THE ISSUE IN DISPUTE
- ATTACHES A COPY OF THE REAL ESTATE CONTRACT THAT CONTAINS THE CLAUSE REFERRING TO MEDIATION
- FORWARDS ALL MATERIAL TO THE MEDIATION PROVIDER SELECTED

THE MEDIATION PROVIDER WILL CONTACT ALL PARTIES TO ARRANGE A MUTUALLY CONVENIENT TIME TO MEET. ALL FEE MATTERS TO BE DISCUSSED BETWEEN PARTIES AND MEDIATION PROVIDERS DIRECTLY If MEDIATION OCCURS AND ALL PARTIES RESOLVE THE DISPUTE WITH A MUTUALLY AGREEABLE SOLUTION
